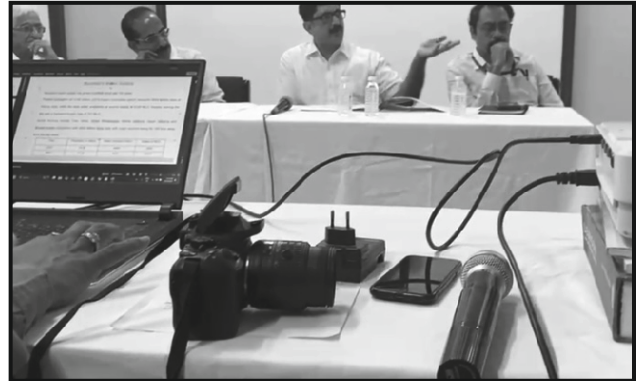
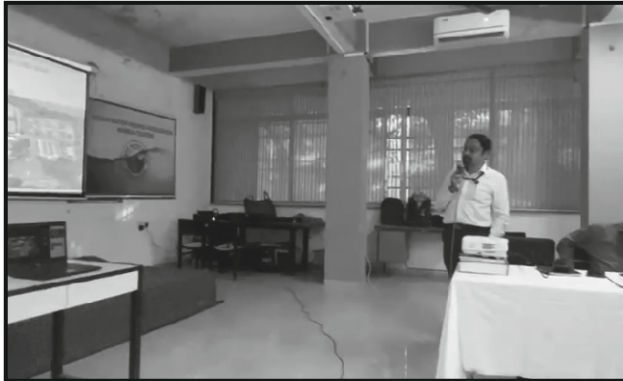

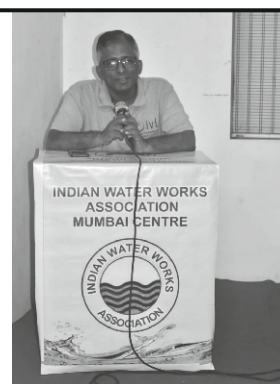
3.0 Technical activities:

Introduction: A workshop was organized by the IWWA (Indian Water Works Association) Student Chapter on 13th August, 2024, at the BMC (Brihanmumbai Municipal Corporation) Planning Department located at Sandhurst Road. The event was conducted for IWWA student members, providing them with a unique opportunity to gain insights into the water management systems and the latest technologies used by the BMC. The workshop commenced with a warm welcome by the officials



of the BMC Planning Department Priyadarshani Kakade madam. The students were introduced to various aspects of water management in Mumbai, with a particular focus on the city's dams and the water distribution network. Then the introduction to water supply network and dams in Mumbai was given by Mhaskar sir. The introduction to the software Water CAD and its working was explained by Madhav sir.

Overall impact: The workshop concluded with an interactive Q&A session, where students had the opportunity to ask questions and clarify their doubts. The BMC officials encouraged the students to consider careers in water management and emphasized the importance of continual learning and adaptation in this field. Above all, the workshop was highly informative and provided the students with a deeper understanding of water management practices in Mumbai. It also equipped them with knowledge of cutting edge tools like Water CAD, which are essential for addressing the challenges of urban water distribution.

Introduction: The IWWA Student Chapter organized a site visit to the rainwater harvesting (RWH) system installed at Chhatrapati Shivaji Maharaj Vastu Sangrahalaya (formerly known as the Prince of Wales Museum) in Mumbai on 11th February, 2025 sharp at 9:30 am. The purpose of this visit was to understand the technical aspects, working mechanism, and impact of the rainwater harvesting system at the museum.

Overall impact: The visit to the rainwater harvesting system at Chhatrapati Shivaji Maharaj Vastu Sangrahalaya provided valuable insights into sustainable water management. The museum's initiative serves as a model for other heritage buildings looking to integrate eco-friendly solutions. Introduction: As part of the World Water Day celebration, IWWA Students Chapter, Department of Civil Engineering, Saraswati College of Engineering, Kharghar, organized an expert talk on 24th March 2025 focused on Sustainable Development Goal (SDG) No. 6: Clean Water and Sanitation. The session was conducted by the distinguished speaker Mr. Anand Jagtap, a renowned expert in the field of urban water management and sanitation solutions.

The visit was part of the Environmental Engineering curriculum, focusing on Water Treatment Plants. The primary objective of the visit was to gain an understanding of the actual functioning of a water treatment plant. Gaining insights into the essential units and technical details of the treatment process and learning about routine laboratory tests conducted on raw and treated water.

3) Visit to Sewage treatment Plant:

A site visit to the Airoli Sewage Treatment Plant was conducted on 18 March, 2025 for third-year Civil Engineering students, organized by Datta Meghe College of Engineering, Navi Mumbai, in collaboration with the Youth Forum of IWWA. This visit formed part of the Environmental Engineering curriculum and focused on key aspects of sewage treatment. The primary objective was to understand the operational aspects of the sewage treatment plant, including its core treatment units and technical processes. Students also observed routine laboratory analyses conducted on both raw and treated sewage.

An international conference titled “Modern Advances in Civil Engineering and Technologies (ICMACET 2025)” was held on 27th & 28th March, 2025, organized by Civil Engineering Department of Datta Meghe College of Engineering, Navi Mumbai, approved by ISTE. The distinguished keynote speaker for the conference was Dr. Pradip P. Kalbar, Associate Professor at IIT Bombay and IWWA Committee Member. Dr. Pradip Kalbar gave his valuable inputs on the topic of “Sustainable Technologies and Solutions for water supply. This unique event provided in depth insights into cutting edge civil engineering technologies and innovations.



6.3 IWWA VJTI Activity held in A.Y. 2024-25

1) Visit to Khoste Village: 19 December, 2024

Civil & Environmental Engineering department of Veermata Jijabai Technological Institute organised a site visit for first yr B.Tech and M.Tech students pursuing community engagement course on 19 December, 2024.

The visit focused on practical exposure to hydrological processes, including scouring and silting phenomena observed in riverbeds in the village. Students also participated in watershed management assessments, analyzing land use patterns, surface runoff behavior, soil erosion control measures, and the impact of human interventions on watershed hydrodynamics. The activity aimed to bridge theoretical knowledge with real-world applications in sustainable water resource management. The visit to Khoste village was an enriching experience for the students and a step forward in strengthening community ties. It provided valuable insights into rural life and reinforced the importance of social responsibility.



2) Visit to sewage treatment plant: 13 December, 2024

A visit was organized for M.Tech students specializing in Environmental Engineering to a sewage treatment plant employing Membrane Bioreactor (MBR) technology. The primary objective was to deepen the understanding of the working principles, advantages, and operational aspects of MBRs in wastewater treatment.

During the visit, students learned about the integration of biological processes with membrane filtration, which enhances contaminant removal and significantly reduces sludge production compared to conventional treatment methods. The hands-on exposure provided valuable insights into the real-world implementation of MBR systems. Discussions also covered the scalability of MBR technology for future applications, emphasizing its role in sustainable wastewater treatment and resource recovery.

Students observed the plant's efficient performance in producing high-quality treated effluent suitable for reuse, underscoring the potential of MBRs in water recycling and environmental conservation. Overall, the visit offered a comprehensive understanding of advanced wastewater treatment technology, bridging theoretical knowledge with practical operational experience.



3) Visit to Waste Water Treatment Plant, Bhandup: 13 November, 2024

A visit to waste water treatment at Bhandup plant was organized by Civil & Environmental Engineering department of VJTI Mumbai for their M.Tech students. The purpose of this visit was to study the wastewater treatment processes employed at the Bhandup Wastewater Treatment Plant (WWTP). The Bhandup WWTP plays a key role in managing wastewater in Mumbai, utilizing a combination of primary, secondary, and tertiary treatment. The focus was on understanding the plant's operational framework, treatment stages, capacity, and compliance with environmental standards.



4) Visit to IFAT Mumbai : 18 October, 2024

M.Tech students from Veermata Jijabai Technological Institute (VJTI), Mumbai, visited the IFAT India 2024, on 18 October, a premier trade fair for water, sewage, solidwaste, and recycling. The visit provided valuable exposure to cutting-edge technologies and sustainable solutions in environmental engineering. Students attended technical sessions and panel discussions on wastewater treatment, water resource management, and integrated waste systems. They interacted with industry professionals, gaining insights into real-world applications of their academic knowledge. The visit also facilitated networking opportunities with experts and organizations working on innovative, region-specific environmental solutions, providing a highly enriching experience that bridged the gap between theory and practice.



5) Visit to Khoste Village: 19 April, 2024

The Department of Civil & Environmental Engineering organized a field trip to Khoste Village for their first year B.Tech and M.Tech students undergoing 'Community Engagement' course, on 19 April, 2024. The B.Tech students conducted a questionnaire survey to gather insights from the local community, which included questions regarding water availability and dependability. The data collected would aid in planning sustainable water management strategies for the village.

On the other hand M.Tech students visited a proposed irrigation dam site and conducted an auto level survey for reservoir capacity estimation. They carried out longitudinal profiling over a 50 m stretch and recorded reduced levels at 5 m intervals. Cross-sectional data was collected across a 20 m width at each chainage point. The survey aimed to support dam design and visualize topographical features for stakeholders.



6) Visit to Bhenshet Village: 18 April, 2024

B.Tech student interns were engaged in designing a water supply system for alternative uses at Bhenshet village on 18 April, 2024. The design and hydraulic modelling & implementation was done in collaboration with IITBAA and IWWA VJTI student chapter. VJTI interns Ronit Thorat and Prashant Chaudhari executed the work under guidance of Prof Pravin Chaudhari.



7) One-Day Workshop on Ferrocement Tank : 02 May, 2024

The Department of Civil Engineering organized a one-day workshop on Ferrocement Tank Construction for undergraduate students 02 May, 2024, under the guidance of Prof. & Head Dr. A.S. Wayal and Prof. Pravin Chaudhari. The workshop provided valuable insights into ferrocement as a versatile construction material with diverse applications. Mr. Ulhas Paranjape, a subject expert, introduced students to its key properties, benefits, and practical uses. Dr. A.S. Wayal complemented this with a presentation on real-world projects undertaken by VJTI students in Khoste village, offering practical context and inspiration. The hands-on session guided students through the preparation of the ferrocement mix, mesh framework assembly, and plastering techniques.



8) An interdisciplinary committee "Technology and Development Solution Committee (Cell) TDSC", Unnat Maharashtra Abhiyan / Unnat Bharat Abhiyan VJTI streamlined the local community development issues and solutions to them.

Basis for Opinion

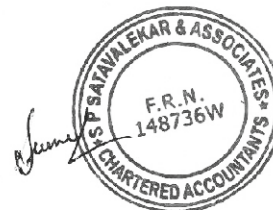

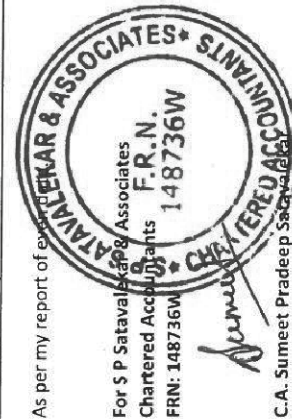
